Sub: Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 - Payment of differential Custom duty along with Interest and Penalty.

With reference to our earlier disclosure made pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 w.r.t. payment of differential custom duty along with interest and penalty on 20th December 2024 and your email dated 21st December 2024, this is to inform you that Company paid Differential Duty of Rs. 57,650 (Inclusive of Interest and Penalty) to The Commissioner of Customs ICD Whitefield, Bangalore for the Short payment of Basis Customs Duty against the goods imported from United States of America (USA).

Details as required under Regulation 30 of the Listing Regulations is attached as Annexure -I.

Reason for delay in disclosure: *We have received email from office of The Additional Commissioner of Customs ICD Whitefield, Bangalore on 10.12.2024 w.r.t. Short payment of Basic Customs Duty (BCD) by the company and it was directed to make the differential duty payment along with interest and penalty within 10 days of receipt of this email but the penalty amount was not clear at that point of time hence after due verification we assessed the differential duty of Rs.57,650/- inclusive of GST Interest and Penalty. Hence we have intimated to the exchange once the liability was assessed and paid on 19th December 2024.*
